Dear parent,

For safer commuting of your ward, kindly note the **"Policy for Regulation of School Cabs"** issued by the Transport Department and the rules laid down that should be adhered for operation of School Cabs. You are hereby informed to acknowledge the same and send the consent form duly filled along with the documents mentioned below by 23/01/2019 to maintain the proper record with the school for the safety of your ward.

- 1. The Vehicle should have a commercial registration with a number of the series DL 1K.
- 2. The vehicle should not be more than 15 years old.
- 3. The Vehicle should have electronic speed governor/mechanical speed control device.
- **4.** The vehicle should run only on C.N.G.
- No overloading is allowed when carrying school children. The School Strongly recommends only 8 children and lady helper in the cab. The number of kids should not be more than one and a half times the carrying capacity in the registration certificate.
- **6.** The Vehicle should have First Aid Box
- 7. The Vehicle should have Fire extinguisher (dry powder type) is mandatory.
- **8.** The Vehicle should have the police verification of the driver is mandatory.
- **9.** The Vehicle should have four amber lights on the top corners of the vehicle.
- **10.** The Vehicle should have carrier for school bags.
- 11. The Vehicle should have a valid insurance.
- 12. The Vehicle should have a board of 250mm × 250mm (with school cab inscribed with bold black letters on golden yellow background)
- 13. The Vehicle should have a convex cross rear view mirrors.
- **14.** The Vehicle should have Name, Address and Telephone number of permit holder (rear exterior of the body).
- 15. The Vehicle should have helpline no. (inside & outside)
- **16.** The Vehicle should have horizontal strip in the middle of 150 mm width in golden yellow colour on all sides.
- 17. Colour of the vehicle: (a) New vehicle White colour (b) In-use vehicle Any colour
- **18.** Ensure that the vehicle is registered with the Delhi Transport Authority.
